Requests

The Dollars in Motion committee meets at the beginning of each month and reviews requests that have been received by the first of the month.

It is our experience that all requests are for a good cause, however, NDTC generally does not contribute to:

- Individuals, groups or organizations that do not reside within NDTC exchanges.
- Benefits or fundraisers for individuals.
- * Organizations of primarily religious or political focus.
- Private business.
- Business / agency / organizational employee events (ie. Christmas parties/employee picnics).
- Sponsorships of sporting teams.
- NDTC does not donate operating costs or recurring services, etc.
